Dear Artist:

It is my pleasure to invite you to submit your intent to participate in the upcoming annual exhibits presented by Centro Cultural Aztlán. This year's fall programming will consist of:

- 48<sup>th</sup> Annual Dia de los Muertos on Sunday, November 2<sup>nd</sup>, 2025.
- 29<sup>th</sup> Annual Zonarte - El Mercado de Aztlán from November 21, 22 & 23, 2025.
- 30<sup>th</sup> Annual Virgen de Guadalupe exhibit, Friday, December 12, 2025 – Jan. 15, 2026.

Please note, this year, El Dia de los Muertos exhibit application has two separate applications, one is for the Artisan Market and the other is for Altar Artists. Please do not fill both unless you are participating in both as a vendor and an altar artist. There will also be an artisan market during the Virgen de Guadalupe opening night, so please fill out the applications and check the “vendor” box at the top of the applications, Check the “artist” box if you intent to submit a piece to the gallery exhibition, or both if you intent to be vendor and have a piece in the gallery.

All entries will be considered; however, we cannot guarantee your acceptance to any exhibit. All applications undergo a selection process to ensure the notifications of acceptance will be delivered on or before the specified dates on the applications. Any artwork sold is subject to a 30% commission. To be part of Zonarte, you will have to inventory all of the work to be sold, and will have to contribute 30% of your sales to Centro Cultural Aztlán. If you have never been a part of an exhibit or market at Centro Aztlán, we require that you send up to 5 samples of your work at the time of your application.

We request that you return the enclosed applications, photos, to Centro Cultural Aztlán no later than Monday, September 15, 2025, to ensure your intent to participate and to be included in all promotional materials. Final decisions will be made once artwork has been delivered. Due to the high volume of entries late submissions will not be accepted. Please refer to the agreements for drop-off deadlines or installation dates. Please note the exhibit times are subject to change.
